Tender Notice For Providing House Keeping Services at

Office of the Commissioner, Patna Division, Patna.

Commissioner, Patna Division, Patna invites Tender from reputed agency with a proven track record to provide House Keeping Services at Office of the Commissioner, Patna Division, Patna with the following conditions:-

- 1) Tender (form and documents) in two parts i.e. Technical Bid and Financial Bid are to be purchased by company/ firm/ agency by **21/06/2023 till 05.00 PM** at the Office of the Commissioner, Patna Division, Patna.
- 2) Minimum eligibility criteria are as below:-
 - (a) Company/ firm/agency should have at least one (1) year experience of providing House Keeping Services in the Government of Bihar/Government of India/Semi-Government or other major institutions.
 - (b) Company's turnover should be minimum Rs. 5,00,000/- (Five lakh) per annum for each three (3) financial year (2019-20, 2020-21 and 2021-2022).
 - (c) Earnest money of Rs. 2500/- (Two Thousand five Hundred) is to be paid along with the technical bid through D.D. in favour of 'Commissioner, Patna Division, Patna' payable at Patna.
 - (d) Company/ firm/agency must provide photo copy of Pan Card, GST Registration and ISO Certification.
 - (e) As the desired 3 Sweepers (unskilled) and 1 Gardener (semiskilled) would be Required, so the agency would quote Service Charge, as per the Finance Department, Government of Bihar vide Circular No. 2988 dated 23-03-2023, the agencies should quote service charge in between 3.85 to 7 % which should be only up to two decimal digits.
 - (f) If the agencies quote 0 (zero) service charge, then both Technical Bid as well as Financial Bid would be completely rejected.
 - (g) The proprietor of Company/ firm/agency must provide his Residential certificate and valid Character Certificate issued from concern district DM/SP/SDO office. Character certificate should not be older than 6 months from date of advertisement of Tender Notice.
 - (h) The agency will have to submit Labour Licence issued by the Labour Department, Govt. of Bihar within 1 (one) month from issue date of Work Order to the agency failing which agency will be debarred from the tender and Earnest Money Deposit will be forfeited.
- 3) Cost of tender document:-
 - (a) Tender document has to be obtained from Office of the commissioner, Patna Division, Patna by payment of Rs. 100/-.
 - (b) The tender document can also be seen (for reference only) on website patnadivision.bih.nic.in. However, it has to be physically purchased from the Office of the commissioner, Patna Division, Patna at cost of Rs. 100/-. Each tender paper purchased from Office of the commissioner, Patna Division, Patna shall be serially numbered and signed. Agency will have to submit tender in the same serially numbered tender document. Each Serialled tender paper will consist of Tender Document and Eligibility and Terms and Conditions in detail.
- 4) The tender will be received in the Office of the commissioner, Patna Division, Patna on **24/06/2023 till 02.00 PM**. The tender shall be opened on **28/06/2023** at **02.00 PM** in which the tenderer or its representative may remain present.
